

# Memorandum Of Understanding (MOU)

In order to prevent misunderstanding or confusion between parties, **SGxKanniyakumari** and **Holycross Innovation and Incubation center (HCIIC)** agree to the following terms and conditions as part of their understanding regarding the services provided by Partner

## Purpose and Scope

The purpose of this MOU is to broadly identify the roles and responsibilities of each party as they move to collaborate in upcoming events and projects.

Both parties are interested in working together in a collaborative manner to promote and foster entrepreneurship and help in the development of an entrepreneurial ecosystem.

## Terms of the MOU

This MOU is effective upon the date last signed and executed by the duly authorized representatives of the parties to this MOU and shall remain in full force and effect until such time as this MOU is terminated / for the period of 2 years. This MOU may be terminated, without cause, by either party upon one (1) month's written notice.

## Chapter Responsibilities

- SGxWorkshops will be organized through HCIIC
- Inspiring, Educating, and Connecting Entrepreneurs
- Helping Incubation Center avail partner offers
- Provide Mentorship and Supports for Entrepreneurship activities at campus.

## Partner Responsibilities

- Venue for the SGx Events
- Refreshments will be provided by the Host
- Attendees/Beneficiaries will be Nominated by the Host



## General Provisions

### → Amendments

Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.

### → Applicable Law

The construction, interpretation and enforcement of this MOU shall be governed by the laws of the state of California. The courts of San Francisco, California shall have exclusive jurisdiction over any action arising out of this MOU and over the parties.

### → No third party liability






