

OUTCOME BASED EDUCATION POLICY

Preamble

Holy Cross College (Autonomous), Nagercoil was established in the year 1965, to

impart quality education to the rural women of Kanyakumari district. The institution is

committed to empower women where academic excellence and skills would help them to face

the competitive world. Having realized the importance of Outcome Based Education (OBE) the

college ventured into OBE in the year 2017. Since then, learning outcome-based curriculum

framework (LOCF), student-centric teaching and learning and assessment are planned to achieve

stated objectives and outcomes. It focuses on measuring student performance i.e. outcomes at

different cognitive levels.

Objectives

The Objectives of the OBE policy is stated as follows:

To design Learning Outcome-Based Curriculum with defined Graduate Attributes and

Programme Educational Objectives (PEO's) in alignment with the vision and mission

of the Institution.

To define Programme Outcomes (PO's) Programme Specific Objectives (PSO's) and

Course Outcomes (CO's) to achieve the graduate attributes.

To establish the criteria by which curriculum is developed or redesigned, instructional

materials are selected, teaching methods are adopted, and evaluation is conducted.

To state the outcome-based assessment rubrics to measure the attainment of outcomes

at course and programme levels.

Roles and Responsibilities

- The committee frames the policies and designs the structure of OBE Curriculum and Evaluation of outcomes.
- The committee shall provide the guidelines to implement attainment of OBE and orient the faculty through training programs, workshops and seminars.
- The committee should have continues monitoring strategies for OBE and shall review the outcome attainments every semester to ensure the effective implementation.
- The committee shall define the Programme Educational Objectives and Graduate Attributes and guide the departments to define Programme Outcomes, Programme Specific Outcomes and Course Outcomes.
- The committee shall ensure the quality assurance of the curriculum, Outcome based teaching and learning and outcome-based assessment of the institution to attain the outcomes.
